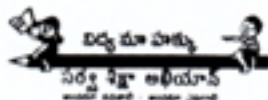

All the District Educational Officers, the Project Officers of RVM (SSA) and the Principals of DIETs in the State are informed that the APRVM (SSA) has been conducting 8 – 10 School Complex Meetings every year with the support of Govt. of India. The Govt. of India has approved only 5-day in-service training to all the teachers in the state for the year 2013 – 14 and no trainings approved at Cluster Level.

Guidelines on the utilization of School Complex Grant
for the year 2013 – 14 is to be utilized under the
following heads and activities.**

a. Contingency Grant – Rs. 6,500/-

- ❖ Maintenance of ROTs
- ❖ Procurement of Registers, Records, Stationary etc.
- ❖ Teacher Reference Books as per the list communicated by SPO.
- ❖ Purchase of Educational CDs.
- ❖ Providing Tea & Refreshments to the participants.
- ❖ Postage & Xerox

b. Meeting and TA Grant – Rs. 2,000/-

- ❖ Conveyance for school visit to the School Complex HM @ Rs. 200/- per month – Rs. 2,000/- per annum (Minimum under schools once in a month) subject to furnishing of school visit report to DPO / DEO
- ❖ Other items if any as per requirement from the savings of the above items.

c. TLM Grant – Rs 1,500/- per annum

- ❖ Procurement of material for preparation of TLM in the School Complex Meetings.
- ❖ Procurement of permanent TLM.
- ❖ Purchase of Educational magazines
- ❖ Other contingencies if any to meet from the savings of the above items.

Further, it is informed that GOI is sanctioned CRC grant only Rs. 10,000/- against Rs. 27,000/- for the year 2013 - 14. It is decided to utilize the CRC grant Rs. 10,000/- for the year 2013 - 14 as follows

1) Contingency	-	Rs. 6,500/- (Contingencies regarding postage, xerox, Registers etc).
2) T.A to SCHMs	-	Rs. 2,000/- (Conveyance to visit under schools)
3) TLM Grant	-	Rs. 1,500/- (Procurement of TLM)
Total	-	Rs. 10,000/-

Therefore, the District Educational Officers, the Project Officers of RVM (SSA) in the state are requested to inform to School Complex H.Ms and MEOs to organize 4 Complex meetings as mentioned above and also see to utilize CRC grant for the year 2013-14 as per guidelines. Further, it is requested to instruct the School Complex HMs to visit under schools every month regularly
